McIntosh County Landowners:

North Dakota Law (NDCC § 4.1-47-02) requires every person to do all things necessary and proper to control the spread of noxious weeds.

FALL 2025 - COST SHARING PROGRAM

There will be cost sharing available for Landowners in McIntosh County, for August thru October spraying of Canada thistle and re-growth wormwood. A limit of cost share dollars is \$30,000 for the whole county, which will be divided to all responders at 80% cost share.

Chemicals and weed control included in the program are listed below.

*Please note that cost sharing is for Milestone **or** GrazonNext HL, **or** Dicamba.*
